LEASE AGREEMENT REVISION ADDENDUM

The Lease Agreement as amended by this Addendum contains the entire agreement of the parties hereto, and no representations, inducements, promises or agreements, oral or otherwise, between the parties, not embodied herein, will be of any force or effect. Except as modified herein, all other terms and conditions of the Lease Agreement shall remain in full force and effect. This Addendum may be executed in multiple counterparts, each of which shall be deemed to be an original, and all of such counterparts shall constitute one document.
- 7. Acknowledgement. YOU ACKNOWLEDGE AND AGREE THAT YOU HAVE CAREFULLY READ AND UNDERSTAND THE LEASE AGREEMENT AND ALL ADDENDUMS AND ACKNOWLEDGE THAT THIS ADDENDUM CONSTITUTES A BINDING AND ENFORCEABLE CONTRACT BETWEEN YOU AND LANDLORD. LANDLORD AGREES TO LEASE TO YOU, AND YOU AGREE TO LEASE FROM LANDLORD, THE PREMISES, SUBJECT TO THE TERMS AND PROVISIONS OF THIS ADDENDUM.
